

DMEL Phase 2

In an effort to continually provide LWR staff and partners with useful and high quality Monitoring and Evaluation tools, the M&E Unit is launching DMEL Phase 2. The structure of the DMEL toolkit will be familiar to everyone, as it still follows the project management cycle. The update includes three new tools and simpler language in the existing tools. It also includes guidance for more thoroughly incorporating gender considerations into projects. See the next page for a chart showing these changes.

New Tools

The toolkit now includes three new tools: <u>Needs Assessment</u>, <u>Baseline</u>, and <u>Monitoring</u>. The <u>Needs Assessment</u> tools include guidance for planning a needs assessment as well as a way to track data collection and triangulation. The <u>Baseline</u> tool is part of the <u>Detailed M&E Plan</u> and provides guidance to collect baseline data. The <u>Monitoring</u> tool will help LWR Country, Regional, and Headquarters staff plan ahead for trips to visit projects and partners, with specific guidance for developing M&E objectives. There is also an <u>M&E Budgeting Tool</u> to help estimate M&E project costs.

In addition to the new tools, each process in the DMEL toolkit has a <u>Checklist</u>, which will help project teams ensure they have done everything necessary before they move on to the next process. These checklists are not required but should be useful to busy project teams.

Updated Tools and Gender Integration

The purpose of the existing DMEL tools remains the same as ever, but the tools have been edited slightly to make them more user-friendly. The <u>Progress Report</u> has been especially edited to reflect feedback from staff members, with a more focused section on project indicators (with accompanying flow chart) and with a new section about participant accountability. In addition to these edits, LWR is working to equip staff and partners with tools that reflect our commitment to gender-inclusive projects, which we believe enable higher-quality, more sustainable project outcomes. We acknowledge that making our projects more gender-inclusive is a process that will take time and more support than just updates to the DMEL, but the gender considerations included in the DMEL tools are practical ways LWR staff and partners can incorporate gender perspectives. A "Learning for Gender Integration" manual will be made available soon and has been written to accompany DMEL tools.

Review and Feedback

Before publicly launching DMEL Phase 2 online in January 2016, the M&E Unit invites all LWR staff and partners to test the new and updated tools for a period of six months, from May to September 2015. The M&E Unit requests your feedback on the new tools, checklists, updated tools, and the gender-inclusive approach of the tools.
